10.32.080 Permit Parking--Private Driveway.

Parking in front of a private driveway shall be allowed only when a vehicle has prominently displayed on the front dashboard a valid parking permit which includes the address of the owner or lessee of the private property, at which the vehicle is to be parked. Permits are valid only at the address contained upon the permit, and is effective while the holder owns or leases the property for which the permit is issued. Permits may be revoked without notice or hearing if it is determined that parking authorized by the permit creates traffic safety or other public health and safety problems. Vehicles creating a traffic hazard may be towed pursuant to Section 10.12.150(B).

Permit does not authorize parking on a sidewalk in violation of California Vehicle Code Section 22500(f).

Requirements to obtain a permit are:

1. Proof of current residency at, or ownership of, the Hermosa Beach property for which the permit is requested or a current business license at the location for which the permit is requested. **Current meaning within the 30-day period preceding the date application is made for the Driveway Parking Permit.**
2. Payment of fee as determined by Ordinance 84-762. **\$38 9/05**
3. Verification that the applicant's registered vehicle(s) has no outstanding parking violations.
4. Driveway must be to a legally established dwelling unit or legally established commercial use structure.
5. The length of the vehicle utilizing the privileges granted by said permit shall not extend beyond the width of the driveway at any point. The width of the driveway shall be that portion between the curb slopes, measured at the street level.

Exceptions:

1. Where signs are posted restricting parking for any other reason, i.e., NO PARKING THIS SIDE, etc. or during certain hours.
2. Entrance to driveway on alleys.
3. Driveways to multiple dwelling parking spaces or multiple commercial use parking spaces.

ORDINANCE NO. 89- 1007

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, AMENDING CHAPTER 19, OF THE HERMOSA BEACH MUNICIPAL CODE, "MOTOR VEHICLES AND TRAFFIC", ARTICLE IV, SECTION 19-61.1, PERMIT PARKING; PRIVATE DRIVEWAY

WHEREAS, it is known that certain driveways are of limited width;

WHEREAS, vehicles parking in front of these driveways may constitute a hazard, or create difficulty for vehicles using the area immediately adjacent for the purpose of parking;

WHEREAS, the City desires to maintain a safe and hazard free environment;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1. That Chapter 19, " Motor Vehicles and Traffic", of the Hermosa Beach City Code shall be and hereby is amended as follows, by adding subsection (e), to Section 19-61.1; and additional language:

Chapter 19

MOTOR VEHICLES AND TRAFFIC

Article IV, Stopping, Standing and Parking, Division 1.
§19-1 -- §19-82

Sec. 19-61.1. Permit parking; private driveway.

Parking in front of a private driveway shall be allowed only when a vehicle has prominently displayed on the front dashboard a valid parking permit which includes the address of the owner or lessee of the private property, at which the

1 vehicle is to be parked. Permits are valid only at the
2 address contained upon the permit, and is effective while
3 the holder owns or leases the property for which the permit
4 is issued. Permits may be revoked without notice or hearing
5 if it is determined that parking authorized by the permit
6 creates traffic safety or other public health and safety
7 problems. Vehicles creating a traffic hazard may be towed
8 pursuant to §19-20 (b) HBMC.

9 Permit does not authorize parking on a sidewalk in violation
10 of CVC §22500F.

11 Requirements to obtain a permit are:

12 (a) Proof of current residence at or ownership of the
13 Hermosa Beach property for which the permit is requested, or
14 a current business license at the location for which the
15 permit is requested.

16 (b) Payment of fees as determined by Ordinance 84-762.

18 (c) Verification that the applicant's registered
19 vehicles have no outstanding parking violations.

20 (d) Driveway must be appurtenant to a legally
21 established dwelling unit or legally established commercial
22 use structure.

23 (e) The length of the vehicle utilizing the privileges
24 granted by said permit, shall not extend beyond the width of
25 the driveway at any point. The width of the driveway shall
26 be that portion between the curb slopes, measured at the
27 street level.

2 1. Where signs are posted restricting parking for any
3 other reason, i.e., No parking this side, etc.; or during
4 certain hours.

5 2. Entrance to driveways on alleys.

7 3. Driveways to multiple dwelling parking spaces or
8 multiple commercial use parking spaces.

10 SECTION 2. That this ordinance shall take effect thirty
11 days after the date of its adoption.

12 SECTION 3. That prior to the expiration of fifteen days
13 after the date of its adoption, the City Clerk shall cause
14 this ordinance to be published in the Easy Reader, a weekly
15 newspaper of general circulation published and circulated in
16 the City of Hermosa Beach.
